Finally - Some Good News For a Change - Ed Zegray

Twenty-nine years after being first subjected to the effects of de-indexation, four years after joining forces with the *Groupe de Travail de associations de retraites (GTAR)* to try to put a stop to the detrimental and escalating losses in our purchasing power, after participating in public demonstrations in Montreal and Quebec, fifteen months after hearings held on this issue by the Parliamentary Commission published its interim report, CARRA's Board of Directors finally struck the Consultative Committee to examine the issues relation to indexation of the pension plans.

You will recall that in its interim report, the Parliamentary Commission on Public Finances, on which sit members from all parties in the National Assembly, recognized the need to diminish, if not to eliminate, the loss in purchasing power of retirees who have been subjected to de-indexation of their pensions for the years 1982-1999. The Commission recommended the creation of a Consultative Committee with CARRA, to examine services to retirees and the parameters of indexation.

Nominations have been completed and the committee is composed of a Chair, 8 retirees and 8 union reps. Representatives from the Treasury Board as well as from the pension administrator, CARRA, will also participate in the discussions of the committee. Of the 8 retirees, 4 have been nominated by GTAR and are: Louise Charlebois (AREQ), André Goulet (AAR), Gisèle Goulet (RIIRS), and Madeleine Michaud (AQRP). The other four retirees are: Arlette Bouchard (RRAME); Rodrigue Dube (ADR); Rosaire Quevillon (ADR-RRAME) and Jean Turgeon (AQDER). The Chair is François Turenne, recently retired Deputy-Minister

The Consultative Committee's mandate is to discuss and propose solutions concerning indexation of the pension plans. While no timeline has been determined at this moment, it begins its deliberations on September 8th 2011. Please note that this is the first time that retirees have been invited on a parity basis as official partners in discussions to determine the future of their pension plans. Finally, the first step in the right direction, that of setting into motion, long-term solutions to this recurrent problem.

THE CANADIAN ASSOCIATION OF RETIRED TEACHERS CELEBRATES TWENTY YEARS OF SUCCESS (1991-2011)

Imagine the vision of the founding directors of ACER-CART in June 1991. They wanted to establish a national association that could lobby at the federal level on behalf of retired teachers and retirees in general. At its inaugural meeting twenty years ago, representatives from nine associations in seven provinces as well as representatives of the Canadian Teachers Federation began to share their expertise.

In 2011, ACER-CART represents thirteen associations. It regularly lobbies the federal government on behalf of over 117,000 members from every provinces and the Yukon Territory. With the collaboration of provincial and territorial organizations, this Canada-wide association deals with pensions, health care and other issues. Member association Directors are able to discuss issues with colleagues from different parts of the country, colleagues who often experience the same or similar problems. Because of the wealth of experience of the Directors, everybody learns from one another and as a cohesive group ACER-CART has been able to influence federal politicians.

At the 2011 AGM banquet, then President Vaughn Wadelius took the opportunity to honour all the past presidents with a short biography of each and a portrait slide show. It was an opportunity to show our gratitude for the efforts of the association founders and its past leaders, and to reflect on past achievements. At the end of the evening, past presidents and executive directors still with us, Johnson Inc, the Canadian Teachers' Federation as well as departing Directors received recognition certificates.

WHAT DO TEACHERS MAKE? A DIFFERENCE!

This was amply reinforced this fall as the MAB-Mackay Rehabilitation Centre unveiled its new low vision clinic funded by two ex-students and named for their self-effacing, tireless advocate of a high school teacher, known to friends as Betty Tate.

Peter and Paul Ash, both visually impaired, vividly recalled their school experiences. Paul spoke of Miss Tate helping him to make sense of what had previously appeared an "intimidating mish-mash of numbers and symbols." She spent countless hours writing out his material with a black felt pen since no enlarging or other technology was available to make things visible for him. She spent further hours replacing the learning he had missed so he remembers feeling "very empowered." Years later when younger brother Peter struggled against low expectations and a diagnosis of "stupid" and "lazy", the family turned to Betty Tate again and Peter's life as a student was utterly changed.

Already well into middle age a few years ago, the brothers told of wondering what outside their family's support had enabled them to succeed despite the early dismal predictions. It wasn't long before they agreed that Miss Tate's high expectations, unending support and powerful advocacy had inspired them to believe in their own abilities and allowed them to move forward to a high level of personal, academic and professional success. Still amazed by the amount of time and effort she spent on them and other students, they decided to pay her back by funding the new C. Elizabeth Tate Low Vision Clinic which they hope will help as many people as she did.

Unfortunately Betty died shortly before the unveiling, but she was alive for the dedication ceremony held when plans for the clinic were finalized. Ex-students, teachers she had trained, family and friends gathered to give testimony to the myriad ways she had shaped their worlds. Betty's friends and those still too respectful to call her anything but Miss Tate won't be surprised to learn she was overwhelmed and astonished by the depth of feeling. We'll miss her and are glad the clinic will remain to help carry on her work.

We were saddened by the passing of Phyllis MacGlashen. Phyllis was a career educator with the PSBGM and after retirement a long time member and friend of QPARSE. For many years she worked with our treasurers to ensure that our financial statements were in order. In her early days, Phyllis was a national level basket ball player and in her retirement was, an avid reader, played bridge and was an excellent cook. She will be greatly missed.

COIN DE FRANÇAIS

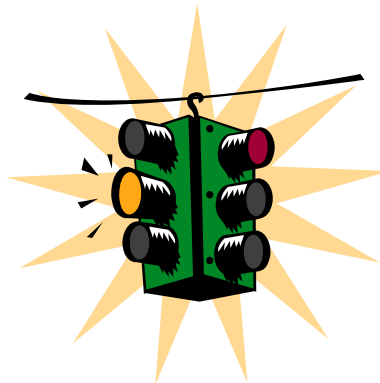
Exemple : Excepté livraison local

You've seen this phrase many times on traffic signs but have you ever wondered why "excepté" in this instance does not agree with "livraison" which is a feminine noun, while "locale" does, hence the "e" added at the end of "locale" but not "excepté".

The grammatical rule here is that there is no agreement when as a preposition "excepté" appears before a noun like in the above illustration. Therefore, it remains unchanged in that phrase.

Generally speaking the term "traffic light" does not allude to anything having to do with fire. Yet the French term "feu de circulation" (meaning traffic lights) contains the word "feu" which translates as "fire" in English. In fact, it was around the year 1188 that "feu" came to mean origin of light in French. (<http://www.cnrti.fr/definition/feu>)

Interestingly enough, "I'm getting off at the next lights" translates as "Je débarquerai au prochain "feu" and not "lumière" (http://66.46.185.79/bdl/gabarit_bdl/asp?t1=1&d=2529) which also means "light" but refers to the kind that brightens a room for instance.

Repeat this procedure for 2 weeks. The next time I see you, you should have lost at least 5 pounds.'

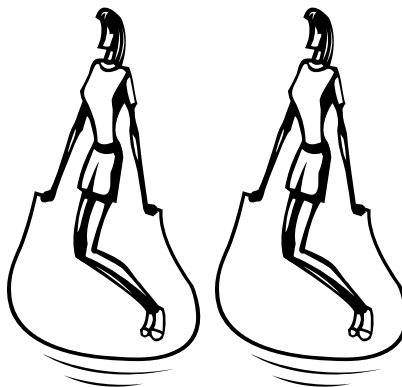
When he returned, he shocked the doctor by having lost nearly 60lbs!
